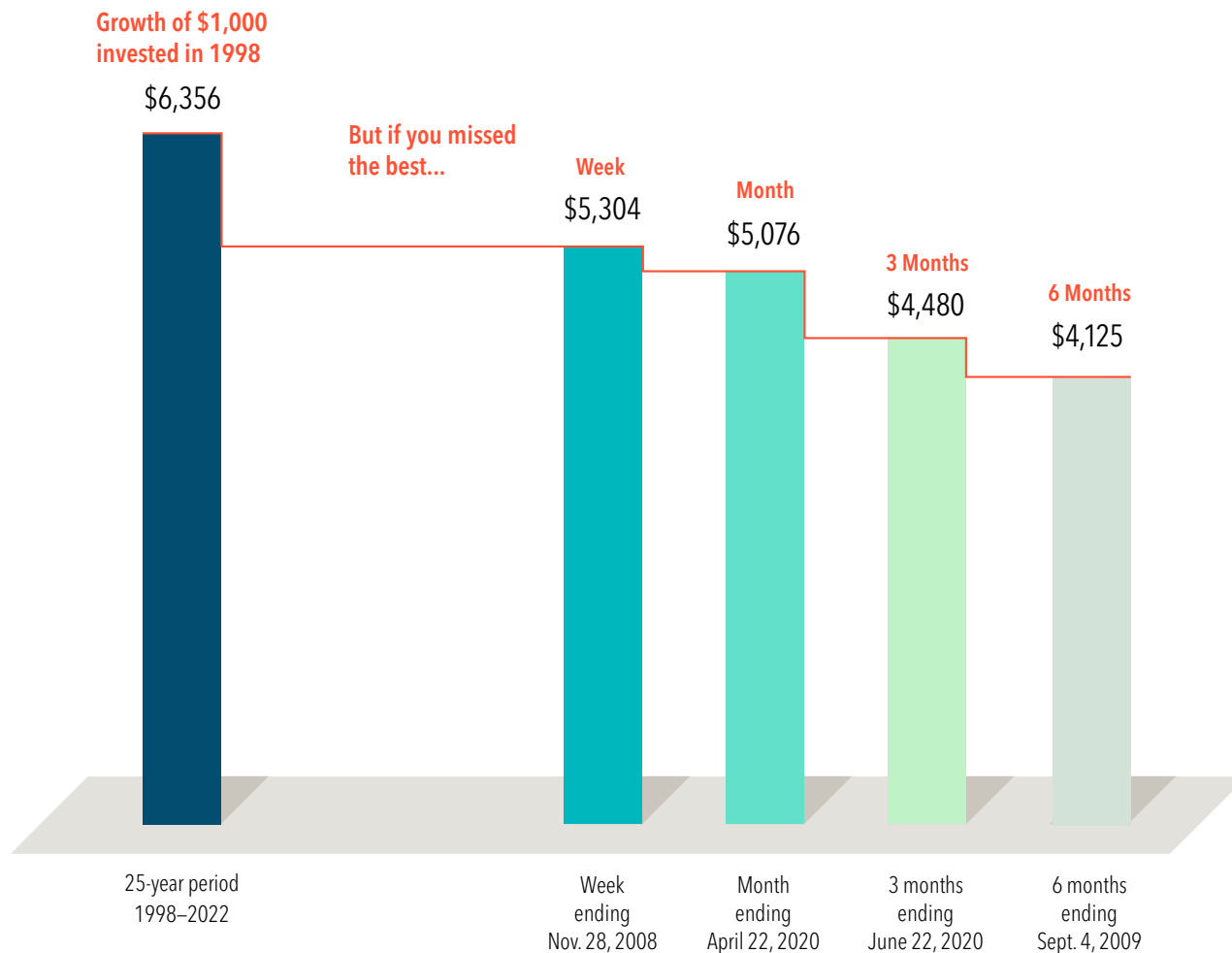


# The Cost of Trying to Time the Market

## MISSING THE BEST CONSECUTIVE DAYS

Russell 3000 Index Total Return, 1998–2022



The impact of being out of the market for a short time can be profound, as shown by this hypothetical investment in the Russell 3000 Index, a broad US stock market benchmark.

- A hypothetical \$1,000 investment made in 1998 turns into \$6,356 for the 25-year period ending December 31, 2022.
- Miss the Russell 3000's best week, and the value shrinks to \$5,304. Miss the best three months, and the total return falls to \$4,480.
- There's no proven way to time the market—targeting the best days or moving to the sidelines to avoid the worst.
